Tuesday, April 7, 2026 – Depart from the USA

Your pilgrimage begins as you depart from the USA.

Wednesday, April 8, 2026 – Depart from the USA

Upon arrival in Tel Aviv, you will be met by your tour guide and driver and transferred to your hotel for check-in and overnight stay.

Thursday, April 9, 2026 – Old Jaffa, Caesarea, Haifa, Mount Carmel, Nazareth

This morning, visit Old Jaffa and the Church of St. Peter, then continue to ancient Caesarea, including the Roman Aqueduct. Travel onward to Haifa and Mount Carmel, visiting Al Muhrakha Church, where the prophet Elijah challenged the priests of Baal, and the Carmelite Monastery and Chapel of the Prophet Elijah. Enjoy panoramic views of Haifa before continuing to your hotel in Nazareth.

Friday, April 10, 2026 – Nazareth, Cana, Mount Tabor

Begin the day in Nazareth, visiting the Church of the Annunciation, the Holy Grotto, and the Chapel of St. Joseph, followed by a visit to Cana, where Jesus performed His first miracle at the wedding. In the afternoon, ascend Mount Tabor, the Mount of Transfiguration, to visit the Franciscan Monastery and church.

Saturday, April 11, 2026 – Tiberias, Sea of Galilee, Capernaum, Tabgha, Mount of Beatitudes, Boat Ride

Drive to Tiberias on the Sea of Galilee and visit Capernaum, where Jesus preached at the synagogue and St. Peter's House. Continue to Tabgha, where Jesus multiplied the loaves and fish, and the Mount of Beatitudes. Enjoy a boat ride on the Sea of Galilee before returning to your hotel.

Sunday, April 12, 2026 – Jericho, River Jordan, Dead Sea, Bethany, Bethlehem

Travel through the Jordan Valley to Jericho, viewing the Mount of Temptation and the ruins of Old Jericho. Visit the

baptismal site on the River Jordan to renew your Baptismal vows, spend time at the Dead Sea, and continue to Bethany to see the Church of Mary, Martha, and Lazarus. Transfer to your hotel in Bethlehem.

Monday, April 13, 2026 – Mount of Olives, Gethsemane, Ein Karem, Bethlehem

Ascend the Mount of Olives for panoramic views of Jerusalem, visiting the Church of Pater Noster and Dominus Flevit, where Jesus wept. Descend to the Garden of Gethsemane, passing the Russian Church of Mary Magdalene, and visit the Basilica of All Nations. Continue to Ein Karem to visit the Church of the Visitation, then return to Bethlehem to see Shepherds' Field, the Church of the Nativity, the Holy Manger, and the Basilica of St. Catherine.

Tuesday, April 14, 2026 – Old City of Jerusalem, Way of the Cross, Mount Zion

Explore the Old City of Jerusalem, beginning with the Church of St. Anne and the Pools of Bethesda. Walk the 14 Stations of the Cross to the Church of the Holy Sepulcher, including the empty tomb of Jesus and Mount Calvary. Stroll through the streets to the Wailing Wall, then visit Mount Zion, including the Church of the Last Supper and Church of St. Peter in Gallicantu.

Wednesday, April 15, 2026 – Emmaus, Our Lady of the Ark, Israeli Museum

Drive to Emmaus, visiting the church commemorating where Jesus appeared to two disciples after His resurrection. Continue to Abu Ghosh to visit the Church of Our Lady of the Ark, and conclude the day at the Israeli Museum, including the Shrine of the Book, which houses fragments of the Dead Sea Scrolls.

Thursday, April 16, 2026 – Return to the USA

After breakfast, transfer to the airport for your return journey home.



PAYMENT INFORMATION

Cancellation Fees

Passengers registering for the tour accept the responsibility for being in good health and able to walk and travel on the tour. Because many of the sites are not accessible to the physically challenged and space limitations on tour buses, wheelchairs and scooters cannot be accommodated. Those needing oxygen or other ambulatory assistance will find the tour extremely limiting in their experiences. Persons using C-pap machines requiring distilled water will need to inform us ahead of time, so we can work with local operators to prepare as it is not always available. Adriatic Pilgrimages reserves the right to refuse or revoke travel to anyone who is, in the sole judgment of AP, incapable of group travel without causing undue demands upon the staff or other tour participants.
